Introduction and Chair's Remarks

Ms. Case provided remarks regarding her time as Chair of the BOTCC. She recognized Electric Reliability Organization Enterprise Compliance Monitoring and Enforcement Program (CMEP) staff for successful implementation of the risk-based CMEP. She noted progress during her tenure on communication of risks, collaboration with the Federal Energy Regulatory Commission, and alignment of activities across the Regional Entities.

NERC Antitrust Compliance Guidelines

Ms. Case directed the participants' attention to the NERC Antitrust Compliance Guidelines.

Upon motion duly made and seconded, the BOTCC approved the November 6, 2018, meeting minutes as presented.

Principles of CMEP Activities

Mr. Kichline presented on the principles that guide activities under the risk-based CMEP. Ms. Senk described the resolutions of high-risk enforcement matters, including mitigation, monetary penalties, non-monetary sanctions, and interaction between the registered entity and the Regional Entity to ensure sustainable compliance, reliability, and security.

CMEP Annual Report

Mr. Noess and Mr. Kichline presented on major CMEP activities in 2018, including the CMEP Technology Project, the Southwest Power Pool RE transition, program alignment, and continued focus on addressing the most significant risks to reliability.

Annual Review of BOTCC Mandate

Mr. Berardesco reported on the NERC Legal department's annual review of the BOTCC mandate. No changes were recommended.
