NERC Antitrust Compliance Guidelines

Stephanie Monzon will review the NERC Antitrust Compliance Guidelines.

It is NERC's policy and practice to obey the antitrust laws and to avoid all conduct that unreasonably restrains competition. This policy requires the avoidance of any conduct that violates, or that might appear to violate, the antitrust laws. Among other things, the antitrust laws forbid any agreement between or among competitors regarding prices, availability of service, product design, terms of sale, division of markets, allocation of customers or any other activity that unreasonably restrains competition. It is the responsibility of every NERC participant and employee who may in any way affect NERC's compliance with the antitrust laws to carry out this commitment.

Participants are reminded that this conference call is public. The access number was posted on the NERC website and widely distributed. Speakers on the call should keep in mind that the listening audience may include members of the press and representatives of various governmental authorities, in addition to the expected participation by industry stakeholders.

- c) Add a requirement to notify UFLS entities and Transmission Owners of the UFLS design requirements and schedule for application
 - i) The team conducted an informal poll to determine support for or against adding a new requirement. The results indicated 5 opposed and 2 in favor.
 - ii) Brian Bartos suggested adding the word or concept "communicate" in R3 to resolve the issue and as a compromise to those opposed to adding an administrative requirement to the standard.
 - iii) Jonathan volunteered to draft a proposal that is limited to Brian's suggestion (not adding a new requirement).
 - iv) Rob communicated that the will be away on vacation beginning the 30th returning the 13th of September.
