

Conference Call Notes Real-Time Operations SDT — Project 2007-03

1. Administrative Items

a. Introductions and Quorum

The Chair brought the call to order at 11 a.m. EDT on Thursday, June 05, 2008. Call participants were:

b. NERC Antitrust Compliance Guidelines — Ed Dobrowolski

There were no questions raised on the NERC Antitrust Compliance Guidelines.

c. Conference Call Agenda and Objectives — Jim Case

The goal of the call was to finalize all of the documents required for the initial posting.

2. Finalize Roadmap Documents

a. TOP-006-1: Steve Myers

Steve verified the references in the deleted requirements.

b. TOP-007-0: Paul Olson

No report was received but the SDT reviewed the document and agreed that it was ready for submittal.

c. TOP-004-2: Ed Dobrowolski

TOP-009-1 was merged into TOP-004-2. The SDT reviewed the changes and agreed that the document is ready for submittal.

d. TOP-001 alternate: Ed Dobrowolski

The alternative wording suggested for the VSL was accepted.



e. TOP-003: Ed Dobrowolski

The term 'without delay' was removed for R6.

3. Discuss Implementation Plan

The Implementation Plan was accepted with one change — the new definition in TOP-002-3 needs to be added to the document.

4. Discuss Issues Database

All of the open items were resolved.

A new definition was proposed in TOP-002-3 for Simulation of Contingencies.

Mike will check within FERC on the NUC-001 resolution references as well as the removal of 'without intentional delay' terminology.

5. Discuss Need for Coordination with PRC Project — Ed Dobrowolski

The SDT feels that the topic is covered. The one contentious issue on the GOP is covered in TOP-001-1, R4. A note will be sent to the project coordinator stating that PRC-001, R2 is sufficiently covered in the TOP standards.

Action Item — Ed will notify the PRC project coordinator that TOP standards cover their concerns.

6. Review Coordination with BAL Project — Ed Dobrowolski

The SDT is comfortable with leaving the BA in TOP-005 for now. A note will be sent to the BAL project drafting team to notify them that the SDT is expecting them to modify their scope to include BA data gathering.

Action Item — Ed will notify the BAL project drafting team of the need to adjust their scope to handle BA data gathering requirements.

7. Next Steps — Jim Case

The SDT agreed that no major changes were made to any of the documents during this call and that therefore the documents can be submitted for posting. A 45 day posting will be requested.



Action Item — Ed will prepare the documents for submittal to NERC staff prior to posting.
