

# Notes Project 2007-03 — Real-Time Operations SDT

#### 1. Administrative Items

# 2. Review Comment Response for Question 2 — Paul Bleuss

However, the SDT does need to feedback the definition of Reliability Directive into the final responses and roadmap(s). #### 5. Finalize Implementation Plan Revisions

There were no additional comments received on the Implementation Plan so that document is final.

## 6. Finalize SOL/IROL White Paper

Some minor grammatical changes were made to this document. A comment was raised about including wording on the administrative burden on entities based on reporting all SOLs, etc. Due to the changes and questions raised, Jim requested one final review cycle for this document. Ed will distribute the document and request any comments through e-mail with the goal of finalizing the document by close of business on Friday, November 13<sup>th</sup>. At that time, the document will be released to the plus list as well as FERC and NERC staffs.
