#### 2. Draft Responses to Request for Interpretation Questions

The team reviewed Bill Middaugh's draft responses. Discussions took place regarding issues around the approved defined terms and included: Protection System, Normal Clearing, Delayed Clearing (Footnote e), and Delayed Fault Clearing. The team agreed that Delayed Clearing (Footnote e) coupled with the ambiguity of defined terms being used in the standard that were not capitalized present difficulty in crafting a response. Mr. Barfield-McGinnis brought attention to the minor difference in Footnote e and NERC glossary term. The glossary has the term "Fault" and the definition is slightly different.

The team discussed the issue of "what is a protection system?" and how to bring clarity to what comprises a system. Struggles included dealing with the functions of a system; in particular, breaker failure schemes. During the course of the meeting, some changes were made to the presented language. Time ran short and the chair suggested assembling a small team to work offline and study the issue in Question one in preparation for the next meeting. The small team of four includes: Doug Hohlbaugh, Bill Middaugh, Bob Pierce, and Patrick Sorrells.
