- J. Calderon initiated the meeting was cancelled, called roll, and reviewed the NERC Antitrust Guidelines and Participant Policy.
- J. Calderon reviewed the table of future meetings and reminded the team to register for the in-person meetings in Atlanta. J. Calderon briefly reviewed the work to date on the current outline and process diagram.

The team continued to discuss the proposed process, which includes a single three-year cycle for performing a risk assessment and annual evaluations of changes to the entity's applicability list that would always look three years out. There was discussion from team members and questions from observers regarding timing expectations for conducting evaluations of the applicability list on an annual basis.

Some concerns highlighted the need to establish a more frequent model exchange, performing more frequent risk assessments for some entities, and ensuring that other aspects of the SAR (the team has not yet developed) would be effectively incorporated.
