- J. Calderon initiated the meeting was cancelled, called roll, and reviewed the NERC Antitrust Guidelines and Participant Policy.
- J. Calderon reviewed the questions sent out to the team January 12, 2024 and the team may like to see another model type represented through this study? In order to leverage models that have already been created, the team may want to look at the 5-year models created by the transmission planner for TPL-001 rather than look at creating a 36-month out model. Either way, the team will consider which model is appropriate, keeping with the expectations of the SAR while not creating unnecessary burden on entities for model development.

The team should also discuss using the same timeframe for all studies rather than having 2 different paths depending on if the entity had previously identified a station as "critical" in a previous risk assessment. This would move away from a 30/60 month cycle that depends on previous results, to having all entities on a single 36-month cycle. The team will continue to emphasize where usage of previous study results may be acceptable to allow entities with a smaller footprint an appropriate level of bandwidth from an obligation to reperform studies. The team deliberated various ways to approach building in this risk-based

approach to allow some usage of past studies and demonstrating that risks are mitigated by having a more frequent applicability list review (annually).

J. Calderon will put together a timeline for the next meeting and begin adding the documented process into the draft.
