### Meeting Objective

### Tuesday, August 19

#### 4. **Determination of Quorum**

The rule for a NERC Standard Drafting Team (SDT) states that a quorum requires two-thirds of the voting members of the SDT. Eight SDT members were present in-person and two SDT members were on the phone, so quorum was achieved.

#### 5. **Review Agenda and Meeting Objectives**

The SDT reviewed the meeting objectives and the components needed for the next posting for comment and ballot.

#### 6. **Low Impact (CIP-003-6)**

The SDT reviewed the outstanding action items for the low impact (CIP-003-6). The SDT continued its review of how to best clarify “external” to demonstrate that the communications are outside the asset or assets containing low impact BES Cyber Systems. The SDT explored the option of using the boundary concept that is used in NIST 800-53, but the SDT wanted to ensure it did not incorporate the Electronic Security Perimeter (ESP) concept. The SDT determined that it should develop definitions for the NERC glossary to help clarify the connectivity for lows. The SDT explored a definition using the boundary option and also explored low impact definitions similar to External Routable Connectivity and Electronic Access Point that are used for medium and high impact assets. The SDT would modify the attachment language accordingly to incorporate the definitions. The SDT also determined it should ensure that the definitions and requirements would not force an inventory of low impact BES Cyber Systems or BES Cyber Assets.

## Wednesday, August 20

### 7. **Low Impact (CIP-003-6) (cont.)**

The SDT continued its discussion of the definitions concept for lows. The SDT noted it was important to keep the language technology neutral and to consider aggregation of assets containing low impact BES Cyber Systems behind one access point.

The SDT discussed how best to address comments on the applicability of the low impact requirements to dispersed generation resources (DGR). The SDT considered whether to revise the applicability of CIP-003 or CIP-002 to address these types of resources. The SDT determined that the DGR standard drafting team should consider potential revisions to CIP-002 or whether to pursue an alternate action to address the comments.

### 8. **Transient Devices (CIP-010-2)**

The SDT reviewed the latest revisions to CIP-010 in the attachment as well as the updated rationale and guidance. The SDT discussed how to demonstrate that the Transient Cyber Assets and Removable should be managed in a manner determined by an entity even if the device only meets the definition once connected to an applicable system. The SDT determined to include language in the attachment stating that entities could manage devices in an on-demand or ongoing manner to ensure the devices meet the requirements in the attachment.

The SDT continued discussion of acceptable use and gold or hardened images. The SDT determined that guidance could be included to further clarify these concepts. The SDT also determined it should develop guidance on scanning between each use of devices.

### 9. **Definitions**

The SDT discussed clarification to “directly connected” and revised the definitions for Transient Cyber Assets and Removable Media to clarify to what the devices would be connected.
