1. Introductions

2. Determination of Quorum

- a. Greg Park, Member presented the draft CLR definition, which had previously been distributed to the SDT members.
 - The SDT has requested a representative from ERCOT (Nitika Mago) review and provide inputs to the draft definition.
 - No action on the draft CLR definition will be taken today, pending review an inputs from Nitika Mago, Observer.
 - o Edits suggested by the SDT members were taken into consideration.
 - Greg will forward the updated draft definition to Laura Anderson, NERC staff, so she can distribute it to the SDT.
- b. Greg Park, member, presented updated document that contained the footnote and discussed topics that limit reductions to IFRO for any reductions.
 - David Lemmons, Chair, drafted language and submitted it by chat and Brad Gordon,
 NERC staff, provided additional edits:
 - "Is not allowed to participate in any other ancillary service, UFLS or UVLS program..."
 - "....and is not used for any other operated initiated emergency operations."
- c. Draft event selection and response calculation: Daniel Baker, Member, was unable to participate in this meeting, so this agenda item will be moved to the May 23, 2022 meeting agenda.
- d. David Lemmons, Chair, presented from Page 18 of 18 of the Draft Version I Reliability Standard BAL-003-3, suggesting that the April 1 and May 15 data requests need to be moved if going to a Section 1600 data request.
 - i. Greg Park added to the discussion to note that FERC Order 714 mandates a due date of June 1st from the previous year.
 - ii. FSRG only provides the actual values, the FRSG FRM.
 - iii. The FERC Order 714 form has a significant amount of work required for that filing.
- d. A review is needed of the reporting instructions from FERC Order 714 as they are today and use in the ERO procedure document.
