This letter gives notice that WECC proposes expedited disposition of the pending violations or alleged violations listed in Attachment B. WECC intends to file with the North American Electric Reliability Corporation ("NERC") and the Federal Energy Regulatory Commission ("FERC") a request to expedite resolution of the pending violation listed in Attachment B and to accept disposition of this violation or alleged violation under the terms of the Agreement in Attachment A hereto, based on the following factors:

- The violation does not pose a high risk to system reliability.
- The violation occurred prior to July 2008.
- The violation has been mitigated with mitigation plan completion verified by WECC.

This proposed expedited disposition will result in the assessment of zero penalties for the violation listed in Attachment B if this disposition is accepted by Black Hills/Colorado Electric Utility Company, LP and by NERC and FERC.
