This letter gives notice that WECC proposes expedited disposition of the pending violation or alleged violation listed in Attachment B. Please review the information below and respond in writing no later than 15 days from the date of this Notice. WECC intends to file with the North American Electric Reliability Corporation ("NERC") and the Federal Energy Regulatory Commission ("FERC") a request to expedite resolution of the pending violation or alleged violation listed in Attachment B and to accept disposition of these violation or alleged violation under the terms of the Agreement in Attachment A hereto, based on the following factors:

- The violation does not pose a high risk to system reliability.
- The violation occurred prior to July 2008.
- The violation has been mitigated with mitigation plan completion verified by WECC.

This proposed expedited disposition will result in the assessment of zero penalties for the violation listed in Attachment B if this disposition is accepted by City of Ukiah and by NERC and FERC.

If City of Ukiah accepts this proposed expedited disposition, sign the attached Agreement and return it to WECC within 15 days after the date of this Notice. If City of Ukiah does not respond within 15 days, WECC will deem this Agreement accepted by City of Ukiah
