This letter is giving notice that WECC proposes expedited disposition of the pending violations or alleged violations listed in **Attachment B**. **Please review the information below and respond in writing no later than 30 days from the date of this Notice.** Responses should be directed to Laura Scholl, Managing Director of Compliance, at lscholl@wecc.biz. If you have questions, please call Ms. Scholl at 801-883-7619. If a timely response is not received, WECC will deem that Colorado Green Holdings, LLC has assented to the proposed disposition and Agreement.

WECC intends to file with NERC and FERC a request to expedite resolution of the violations listed in **Attachment B** and to accept disposition of these violations under the terms of the Agreement at Attachment A, based on the following factors:

- The violations are confirmed because Colorado Green Holdings, LLC previously agreed to WECC's proposed disposition of the violations as provided in a Notice of Alleged Violation and Proposed Penalty or Sanction ("NAVAPS"), **or** the violations are confirmed because WECC issued a NAVAPS and Colorado Green Holdings, LLC did not contest the violations or proposed penalties within the allowed time;
- The violations do not pose a high risk to system reliability;
- The violations occurred prior to July 2008;
- If fully processed according to the Compliance Monitoring and Enforcement Program, the violations likely would result in recommendations of zero-dollar penalty; and
- The violations have been mitigated with mitigation plan completion verified by WECC.




