Reference: Revisions to Rules of Procedure

Dear Mr. Berardesco:

On December 7, 2015, North American Electric Reliability Corporation (NERC) submitted proposed revisions to its Rules of Procedure. NERC states that the purpose of these revisions is (i) to be consistent with the terminology used in Critical Infrastructure Protection Reliability Standards approved by the Commission in Order No. 791, (ii) align the definitions of terms in Appendix 2 of the Rules of Procedure with the Glossary of Terms used in NERC Reliability Standards,¹ and (iii) reflect previously approved revisions to the NERC Standard Processes Manual.

Notice of this filing was issued on December 8, 2015, with protests and interventions due on or before December 28, 2015. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure. 18 C.F.R. § 385.214. No protest was filed.

NERC's uncontested filing is accepted pursuant to the relevant authority delegated to the Director, Office of Energy Market Regulation, under 18 C.F.R. § 375.307, effective April 1, 2016, as requested.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order pursuant to 18 C.F.R. § 385.713.
