Briefly describe the nominee's experience and qualifications to serve on the RISC:

Mr. John Babik is JEA's Chief Compliance Officer acting as the Director of Electric Compliance. He is a regulatory compliance and audit professional with over 35 years of experience in the utility industry specializing in interpreting and executing NERC and NAESB standards for four of the seven regulatory entities (SERC, NPCC, RFC, & MRO) for the past 20 years he has been a key player in the assessment of legal and regulatory issues in the evolving electricity industry as well as in the development of emerging reliability standards activities and their processes. Recent activities includes: NERC Standards Committee representing Segment 1. Took the lead in developing technical comments to Standards TPL-001-5 by providing guidance for all Trade Associations in preparation to reply to the FERC proposed directives (NOPR RM19-10-000) for this standard. Also, previous task force member of the High Altitude Electric Magnetic Pulse (EMP) team experts to lead in the development of drafting the EMP Task Force Strategic Recommendations. The task force was charged to develop recommendations on developing best practices and reliability guidelines to mitigate the impacts of an EMP incidents.

In his current position, he is responsible for JEA's NERC compliance efforts and the coordination of reliability standards compliance activities within the SERC region and represents JEA on the SERC Technical Committees (OC). Mr. Babik has served in a number of positions in NERC and the five regional standing committees representing the Operating, Planning and the Compliance Committees. He also served on the NAESB WEQ Executive Committee – Generation Segment. Active member of the LPPC Reliability Task Force.

Mr. Babik's major career experience has been in the Electric Regulatory Compliance, Grid Operations & Planning, Transmission & Substation Engineering, and RTO integration projects.
