Wu. Mr. Wu noted the full antitrust guideline, participant conduct policy and public announcement were provided in the agenda package to each member via email and posted on the PMOS webpage.

Consent Agenda

The meeting agenda was reviewed. The chair made a motion to approve meeting minutes from February 20, 2024, PMOS meeting. Donovan Crane moved the motion and Ruida Shu seconded the motion. The meeting minutes were approved by the PMOS liaisons.

PMOS Action Items:

Project Tracking Spreadsheet Review and Project Timeline Verification and Updates

Project 2020-02; 2020-06; 2021-03; 2023-03; and 2023-04

Ben will follow up on the project timelines and adjust accordingly. The "Summary" tab indicates that there is one project approved by industry and ready for final ballot; additionally, there are two (2) projects seeking nominations and SARs; six (6) projects undergoing active development; and three (3) projects posted for balloting and commenting.

Project 2022-04

A new Developer has been assigned to Project 2022-04. While this project has been "classified" as a low priority project (as of this meeting date), the team is continuing to meet about every two weeks.

Project 2023-04

This project nearly passed industry, with an approximate 60% approval rating during the last balloting and commenting period. Modifications made to the draft were well-received by industry; however, near the end of the comment period, concerns developed regarding remote access.

Meeting schedule for 2024 was reviewed. Dates could be changed if they need to be changed. No one has concerns with the schedule at this point.

PMOS leadership was very engaged in the Project 2020-06 and Project 2022-03 updates. One leader suggested holding industry-wide workshops, similar to workshop(s) held when significant changes were made to the BES Definition, to listen to industry's concerns and gain industry consensus. He discussed logistics, planning, coordination, and timing.

Other

PMOS Scope and Responsibilities: A PMOS Focus Group was created. Besides the chair and vice chair of the PMOS, the following liaisons have volunteered: Claudine Fritz, Jennifer Richardson, Jason Chandler, Donovan Crane, Sarah Habriga, Ruida Shu, as well as Jim Howell from the Standards Committee.
