



The speed at which risks to the reliability, security, and resilience of the bulk power system are emerging during the transformation to a decentralized, digitized, and decarbonized grid is outpacing industry's ability to develop, enhance, and implement Reliability Standards under the existing processes and procedures. At its February 2025 meeting, the NERC Board of Trustees passed a resolution forming an industry-led Modernization of Standards Processes and Procedures Task Force (MSPPTF) to undertake a strategic review of NERC's Reliability Standards development process. The task force will present proposed recommendations to the NERC Board in February 2026.

2025 August Update

Background

The MSPPTF is focusing on transforming current processes and procedures to ensure that standards can be developed more efficiently and effectively to better address the complex and rapidly evolving risk landscape.

Key Activities

The MSPPTF has posted for comment a white paper on potential improvement opportunities in three areas: standards initiation, standards development, and balloting. The task force hosted a stakeholder webinar on July 21 to provide context in advance of the white paper's release on July 22. More than 375 stakeholders participated, reflecting the level of interest and the importance of the initiative. The white paper was informed by input from a stakeholder survey and is posted for stakeholder feedback through 11:59 p.m. Pacific, August 27, 2025.

The task force will host three virtual Q&A sessions to provide useful context to facilitate stakeholders' responses.

Stakeholder Outreach

Task force members continued to socialize the MSPP initiative at NERC committee meetings, including at the Standards Committee, Compliance and Certification Committee, Reliability and Security Technical and Committee, the Member Representatives Committee Informational Session. Additionally, the task force kicked off a series of MSPPTF-focused events with Regional Entities, including a segment on ReliabilityFirst's July Tech Talk during which two task force members presented to over 270 attendees. More Regional Entity-hosted events are planned for August and are listed here. Task Force members have also been active in their respective trade organizations presenting at working group and committee meetings, and through informal conversations with peers. With the release of the white paper, the task force members are gearing up for a busy August and are eager to receive extensive feedback to inform next steps.
