Mr. Villar pointed out that "FRCC System Disturbance and Underfrequency Load Shedding Event Report" from 2008 is worth reading and that event might have something to do with power swing blocking.



- c. G. Henneberg also shared that IEEE is currently working on a technical report related on Power Swing Relaying. Mr. Henneberg will provide a "draft" IEEE report to the group (A1).
- d. Ben Wu will follow up on "FRCC System Disturbance and Underfrequency Load Shedding Event Report" for next meeting's discussion (A2).
