## 2. Review FERC Order 733, Requirement 2, Attachment A

- a. The SDT members continued to discuss the options to either retire or revise Requirement 2 (R2). A few tasks were assigned to some SDT members (see below).
- b. J. Villar shared "FRCC System Disturbance and Underfrequency Load Shedding Event Report" from 2008 before the meeting. SDT members did not find any evidence that Power Swing Blocking played any part in blocking relays from responding to the prolonged fault.
- c. M. Patel was assigned to draft proposed language on exclusions if the SDT decides to keep R2 (A1).
- d. C. Koteles was assigned to clarify how much time a Registered Entity has between the Requirement 6 identification and implementation of relay settings (A2).
- e. G. Henneberg will draft the proposed language for new Requirement 2 (A3).
- f. D. Lin was assigned to work on the Supplemental Technical Reference Document, "Determination and Application of Practical Relaying Loadability Ratings Version 1", referenced in PRC-023-4, as needed to address these modifications, specifically, the Out of Step Blocking [Power Swing Blocking] section (A4).
