Announcement: Standards Recirculation Ballot Windows Open

The recirculation ballot period for the following standards will run from 8 a.m. Eastern Prevailing Time (EPT), April 17 through 8 p.m. EPT, April 26, 2006. The Standard Authorization Committee urges ballot pool members who wish to change their initial vote and ballot pool members who did not vote during the initial ballot period of March 21 through March 30, 2006 to register their votes during this period.

- Take no action if they do not want to change their original vote.

In the recirculation ballot, votes are counted by exception only — if members don't indicate a revision to their original votes, the vote remains the same as in the first ballot.
