b. NERC Antitrust Compliance Guidelines

There were no questions on the NERC Antitrust Compliance Guidelines.

c. Review Meeting Agenda & Objectives – John Odom

The goal of this call was to come to a consensus agreement on the concepts expressed in the new TPL-007 and finalize language where possible. The overall goal is to have the first posting prior the July meeting in San Francisco.

2. Review Draft Language for TPL-007-0 - Ed Dobrowolski

We need to check on whether this should be -0 or -1. There was some thought that making it a -0 would cause confusion as people associate -0 with the initial move from guidelines. Ed will check with Maureen on the correct numbering scheme.

It was noted that PRC-024 also addresses ride through issues and therefore should be cited as an associated standard.

Changes agreed upon during the call were shown as red-line corrections and the revised document was distributed to the team following the call via the mail server.

We need better clarification between studies and assessments as well as further definition of the differences between plant and system stability. Bob Jones will attempt to come up with new wording that reflects these changes and have it available before the next conference call.

3. Develop Questions for First Posting

Time did not permit a review of questions during the call. John Odom and Bob Millard will work on creating a set of questions that will be distributed to the team, which will be edited via e-mail.

We will continue to work on developing the language for the first draft.
