- Transmission Agency of Northern CA the SDT was okay with this response.
- Tenaska Move R3.3.2.1 to a new R2.9. Delete R3.3.2.2 but move words to note on System adjustment. This will necessitate a review of comment responses for proper requirement numbering.
- ITC—the SDT was okay with this response.
- City of Tallahassee a correction is needed to P6. The response needs to be re-worded to emphasize footnote 10.
- Center Point Re-word the second paragraph of the response and provide an answer on the Stability question.
- MISO the SDT was okay with this response. This response can be used for Center Point.
- Tri-State The SDT was okay with this response but probabilities in the table should be deleted.
- Lakeland Strike the second sentence in the third paragraph.
- Southern you can't use the word 'requirements' in the Table.
- ERCOT the SDT was okay with the stuck breaker response. The protection system response needs to be correlated with the NPCC response. The SDT was okay with the response on asset owners.
- FE Extreme Event 2e is retained from the original as it can still cause harm.
- c. Q8 Tom Mielnik

Tom had several spots where he needed the final wording on footnotes. He will use the output from today's call to finalize his responses.

d. Q10 — Bob Millard

A final clean-up is required and it should be available for distribution by the end of the week.

e. Q15 — Darrin Church

There are about 600 different issues to address in question 15. The team is about fifty percent complete with their individual work but then the answers need to be put together and correlated for consistency. A full SDT review and buy-in will be required.
