The team reviewed the CIP-010 (question six) comments received. Due to the amount of comments received, more than one meeting will be needed for review. Below outlines the high level themes/notes captured by the team during review.

- Prescriptive list
- Weaken language and increase in scope
- Check verb in parents requirement R1
- Backwards compatibility still needs work
- 1.1 to 1.3 consistency (clear tie between the two) and 2.1
- address open source and firmware in the software statement
- Measure 3.3. Look at the word "any" update with "where tools are used"
- try to get this sub requirement to focus on verifying what you did change and not make it seem to be a complete CIP-005 and CIP-007 compliance check
- Add baseline back
- Requirement R1 Part 1.1. ripple effect
