The SDT discussed why the "containing assets" language was removed from 3.1 of attachment 1. It was removed from each part, and added to the main bullet for consistency and clean up.

2. CIP-005

The SDT reviewed minor changes regarding consistency of the phrase "routable protocol" and determined that the phrase must be reflected in 1.2 and 1.3 of CIP-005. The team added "routable protocol" to 1.2.

3. PCA Definition

The team reviewed the PCA definition. It was questioned if "excluding VCA" needs to remain in the PCA definition due to it being stated in the VCA definition. It was determined to leave "excluding VCA" in the PCA definition for clarity purposes.
