3. Proposed Revisions

The SDT transferred Requirements related to authorizing and managing access to BES Cyber System Information storage locations from CIP-004 to CIP-011. The following sub-requirements were moved: Requirement R4, Parts 4.1.3 and 4.4, Requirement 5, Part 5.3. Requirement R5, Part 5.4 was revised to remove the reference to Requirement R5, Part 5.3, which was moved to CIP-011.

CIP-011, Requirement R1 was expanded to further clarify what should be included in the information protection program to focus on the controls. Requirement R2 was revised to clarify that BES Cyber System Information and other sensitive materials will be sanitized before reuse and disposal of Cyber Assets. Requirement R2, Part 2.2 was deleted due to the revision of Requirement R1.

The SDT will continue to revise language for Requirement R1 regarding the access management program related to information (including access revocation and periodic review of access).

4. Supporting Documentation

SDT Assignments were made to the respective supporting documentation needed for the project.

L. Harkness reviewed the timeline with the SDT for finalizing documentation for the initial ballot and posting scheduled for October.
