# **MOD-025 Comments, Themes, and Responses**

- The MOD-025 sub-team reviewed responses for Question 3-4 at the February 17, 2023 public meeting
  and focused their efforts on response to comment for Questions 1, 2, and 5 during additional working
  meetings.
- The SDT finalized their responses from Questions 3-4 (Requirement R3/R4) and Question 1-2 (Requirements R1/R2). Several of the responses to Questions 1-2 resulted in changes to Requirement R1/R2 and Attachments 1-3.
- Question 5 responses and associated revisions will be the focus during a working meeting scheduled for March 16, 2023.
- The SDT set a goal of completing responses and revisions to MOD-025 by the end of March 2023, in order to begin quality review.
- Next steps:
  - March 16, 2023 working meeting to focus on remainder of Question 5 responses
  - March 31, 2023 goal for pencils down
  - Schedule an in-person meeting reserved for response to comments after the additional posting
