Additionally, several standards have been created/revised since the implementation of FAC-008 which focus on data collection for system planning and operation. The SAR DT has determined that an examination of these standards is appropriate to streamline the data collection requirements and ensure accurate generator ratings are reflected in studies and models. This examination will seek to reduce administrative burdens while maintaining a high-level of data collection for reliability purposes.
