- a. D. Mulcahy offered that the most poignant comment received was ERCOT's comment on the scoping of the SAR effort, including potential limitations of applicability and the requirements for CAP. The thought is one that the SAR could differentiate the necessity of CAP because of the differences between operating and planning horizons.
- b. The SAR DT discussed on the inclusion of the word "potentially" being tied to the development of CAP, OP, and mitigating actions. There were a number of scenarios presented.
- c. The SAR DT discussed about the language addressing what happens when pre-determined criteria exists or not. Language was provided to satisfy the concern on how a standard "would" require PDC alternatively.
- d. There was a question on whether or not the ERCOT offered comments were only to the planning SAR or should be the same for the operating SAR. Comments would apply to both SARs.
- e. D. Thompson discussed next steps SARs comments will be emailed for review and vote. If SARs revisions meet quorum, the revised SARs will be submitted to the SC in January to seek approval and to authorize standard development.
