Nomination Period Open for Project 2021-07 – Extreme Cold Weather Grid Operations, Preparedness, and Coordination

NERC is seeking nominations for Project 2021-07 Standard Authorization Request (SAR) drafting team members through **8 p.m. Eastern, Tuesday, December 21, 2021**. The time commitment for this project is expected to be two face-to-face meetings per quarter (on average two full working days each meeting) with conference calls scheduled as needed to meet the agreed upon timeline the team sets forth. Team members may also have side projects, either individually or by sub-group, to present for discussion and review. Lastly, an important component of the team effort is outreach. Members of the team will be expected to conduct industry outreach during the development process to support a successful ballot. Previous drafting team experience is beneficial but not required. By submitting a nomination form, you are indicating your willingness and agreement to actively participate in face-to-face meetings and conference calls.
