# **NEW Standards Committee Nomination Results and Election**

The Standards Committee (SC) nomination period for the special election for Segment 1 to fill the remainder of the 2023–2024 term closed November 27, 2023. Amy Casuscelli and Jamison Cawley were nominated to represent Segment 1. An election began on Wednesday, December 6, 2023, for Segment 1 and will remain open until Monday, December 18, 2023 at 8:00 p.m. Eastern. Each individual or entity that is a member of Segment 1 may vote. Detailed information on each candidate is posted on the <u>Standards Committee's Nominations and Elections web page</u>. Click <u>here</u> to vote if you represent Segment 1. Proxies are allowed; proxy designations should be emailed to <u>Katrina Blackley</u> prior to voting.

In accordance with the Procedure for Election of Members of the Standards Committee contained in Appendix 3B of the NERC Rules of Procedure, to be elected, a nominee must receive the highest total number of votes in that Segment and receive a simple majority of the votes cast in that Segment.

#### **NEW RSAWs Posted**

NERC has posted new Reliability Standard Audit Worksheets (RSAWs) for FAC-001-4 and FAC-002-4 to the RSAW homepage under the heading "Current RSAWs for Use." These standards become effective January 1, 2024. FAC-001-4 seeks to ensure that Transmission Owners and Generator Owners make Facility interconnection requirements available so that entities seeking to interconnect will have the necessary information, while FAC-002-4 seeks to ensure that the impact of interconnecting new or changed Facilities on the Bulk Electric Systems is studied and contains requirements for Planning Coordinators, Transmission Planners, Transmission Owners, Distribution Providers, and Generator Owners.

RSAWs are guides provided by the ERO Enterprise that describe types of evidence that registered entities may use to demonstrate compliance with a Reliability Standard. RSAWs also include information regarding how the ERO Enterprise may assess that evidence. RSAWs do not require specific evidence to be provided, and they are not intended to require a single, exclusive approach to assessing compliance with a Reliability Standard.

#### **OTHER NEWS**

#### NEW Save the Date for 2024 NERC-NATF-EPRI Extreme Weather Transmission Planning and Modeling Workshop

NERC, the North American Transmission Forum (NATF), and the Electric Power Research Institute (EPRI) will be holding a seminar on transmission planning for extreme weather on January 17, 2024. This seminar will focus on weather and climate data criteria and characteristic needed to establish network models for extreme weather per FERC Order No. 896 and how to identify and develop benchmark planning cases for extreme heat and extreme cold. The standard drafting team for TPL-008 will be releasing the draft standard for review at the start of February 2024, this workshop will provide context and the scientific basis for decisions included in the standard. In addition to the necessary transmission planning practices to develop weather impacted power flow cases, attendees will also hear from climate experts from National Labs and Agencies who will discuss the science behind climate impacted weather data in the long-term transmission planning timeframe. The event will be held virtually, and more details will be announced closer to the workshop.
