REMINDER MSPPTF Stakeholder Survey

The Modernization of Standards Processes and Procedures Task Force (MSPPTF) has identified areas for improvement in the standards process and is conducting a deep dive into three areas of opportunity: 1) standards initiation/standard authorization requests, 2) standards development/drafting, and 3) balloting. As part of this initial phase, the task force is seeking input via a [survey](#) that provides an opportunity for stakeholders to offer ideas for consideration to transform current processes to more effectively address the complex and rapidly evolving risk landscape. Please complete the survey by 11:59 p.m. Pacific on **Thursday, June 5**. All responses are anonymous. While the task force will not directly respond to specific comments, feedback will be considered by the task force as it develops its initial outline of recommended changes that will be posted this summer for additional stakeholder input.
