On February 27, 2019, the North American Electric Reliability Corporation ("NERC"), Florida Reliability Coordinating Council, Inc. ("FRCC"), and SERC Reliability Corporation ("SERC") submitted a joint petition for approvals in connection with dissolution of FRCC's Regional Entity function.
