2. Review of NERC Process and SC Expectations

- a. "Getting Started" Presentation Mr. Taylor presented information for the SAR DT regarding roles and responsibilities as well as the standard development process
- b. Review of Drafting Team Guidelines Mr. Crutchfield reviewed the highlights of the guidelines.
- c. Review of Drafting Team Scope Mr. Crutchfield reviewed the highlights of the scope document.
- 3. **Review SAR** Mr. Robinson presented a review of reactive power and reviewed the basics of the whitepaper that was developed by the TIS. The group discussed the SAR and developed a direction for revising the SAR based on comments received. The SAR DT will limit the VAR standards to Year 1 (up to 18 months) and the TPL standard will apply to longer term planning. The SAR DT also agreed to replace the



- "cluster" term with appropriate functional entities. Mr. Robinson agreed to revise the SAR overnight and provide it for review.
- 4. **Review and respond to comments received on SAR** Mr. Simpson led a review of all comments on the SAR. The team discussed whether our revisions to the SAR would address the comment. The team also reviewed the redraft of the SAR that Mr. Robinson developed.
- 5. **Review Action Items / work plan** The team developed the following plan:

 - ii. Mr. Crutchfield will assemble a complete document to re-send to team by end of year.
 - iii. Team will do secondary review and finalize SAR by January 11, 2010. Mr. Crutchfield to schedule WebEx for January 7 at 1-3 PM EST.
 - iv. Submit second draft of SAR to TIS on January 12, 2010.
 - v. TIS to review/approve SAR at January 19-20 meeting
 - b. Consideration of Comments
 - i. Messrs. Simpson, Harm, Robinson and Crutchfield to develop responses to comments to send to team for review. December 21st.
 - ii. Team to review / comment by COB January 18, 2010.

 - c. Submit both documents for NERC Staff review February 1, 2010.
