- e. Question put to informal poll of the team: Do we want to change B space measurement time 20 to 52 seconds?
 - Rich Hydzik It would give 6 seconds if leave as-is. Opposed to changing B space.
 But then why did the SDT need to change A space?

 - Greg Park opposed.
 - Danielle Croop abstain.
 - Daniel Baker abstain. The language applied to A space should be applied to B because of what we just applied to A.
 - o Bill Shultz opposed.
 - Antonio Franco opposed. No statistical analysis to support it.
 - o Josh Boone opposed.
- f. The SDT determined that it does not have the bandwidth to do a statistical analysis so no change to B space. There is currently no reliability impacts to leaving it as-is.
