

Project 2021-04 Modifications to PRC-002 Phase II Standard Drafting Team Meeting

Introduction and Chair's Remarks

The meeting started at 11:00 a.m. Eastern.

NERC Antitrust Compliance Guidelines and Public Announcement

The NERC Antitrust Compliance Guidelines, NERC Participant Conduct Policy, and the Public Announcement were presented and reviewed by the secretary.

Agenda Items

1. Introduction

- a. The Chair welcomed the Standard Drafting Team (SDT) members and the participants from the industry. See **Attachment 1** for those in attendance.
- b. The agenda was reviewed and approved by the SDT.
- c. B. Wu briefed the SDT on the pros and cons of creating a New Standard vs. Modifying the existing Standard to address the IRPTF (IBR related) SAR. Ben pointed out that the revised SAR did not check the box where it says creating a new Standard when the SC was asked to approve. This might create some administrative work. If the SDT believe that creating a new Standard is absolutely beneficial, the extra administrative work could be taken care of. Ben also pointed out that if a new Standard is created, it would be the next (PRC) number available (such as PRC-028-0), it will not be PRC-002-IBR (this convention only applies to Regional Standard, not at NERC). Ben advised the SDT to move forward with modifying the existing Standard.
- d. B. Wu also updated the SDT on the status with IBR definition. The term is not defined currently in the NERC Glossary of Terms. There are another Projects (Project 2020-06 and Project 2021-01) involving IBR. The other SDTs decided to use a footnote rather than define IRB. This SDT decides to do the same.

2. Develop Draft of Standard, Implementation Plan, VRFs and VSLs

- a. IRPTF (IRPWG) SAR was reviewed.
- b. The SDT continued to work on the Standard.
- c. The SDT did not start to work on the Technical Rationale document.



d. Future in person meeting is proposed. It is tentatively scheduled for April 4 and 5, 2023. It will be either at the NERC office or in Arizona.
