- a. IRPTF (IRPWG) SAR was reviewed. The chair went over the background and work scope at the meeting.
- b. The chair reviewed the notes from previous meetings (6/1/2022, 6/22/2022, 7/27/2022)
- c. The SDT discussed whether a hybrid facility (wind/battery, GT/battery, etc.) with a small BESS would be applicable or the IBR solely needs to exceed 75 MVA. There is a CMEP Practice Guide for hybrid resources.

The SDT discussed the option of making this (phase 2) project being focused on IBR. If they go the route of a new standard for just IBR wouldn't that require restarting the SAR process?
