## 2. Gaps/Issues On Large DER Owners But Not Registered As DPs

Ben Wu reminded the team that making sure to close gaps when LSEs are replaced by DPs per registration because some large DER owners are registered as LSE but not DP.

#### 3. Develop Draft of Standard, Implementation Plan, VRFs and VSLs

The team made the following proposed modifications in attachment 1:

The sub-bullet list for the added DER data requirements (Jonathan volunteered to review the DER\_A parameterization reliability Guideline to identify if additional items should be included in the "dynamics" column). In general, team feedback is requested on the need to specify subbullets for the dynamics column or leave the dynamics column without sub-bullets similar to other items in the existing table.

Modifications I made to footnote (2) clarifying the need for gross Demand rather than net Demand.

Modifications I made to footnote (4) to identify TP/PC options for aggregated/unaggregated data and potential coordination with DP/TO regarding equivalent impedance.



Improvement/clarification of the proposed parenthetical language "when Demand/DER is not associated with a registered DP".

Is a DER definition needed in the NERC Glossary of Terms? Anything else we are missing that is needed to cover the MOD-032 SAR scope?

The SDT would like to schedule an in-person meeting in the near future. Ben Wu asked volunteers to host. The team members are in favor of going to the NERC office in Atlanta due to the location and weather. The time was proposed for January 11 and 12, 2023. Ben Wu will check the availability of the conference rooms.
