Comment Period for Errata in Approved Reliability Standards Open for 30-day Comment Period

A set of errata in approved reliability standards is posted for a 30-day comment period from July 2–31, 2008.

There are several approved NERC Reliability Standards that contain errors that, if corrected, do not change the scope or intent of the associated approved standard and do not have a material impact on the end users of the standard. These errors identify discrepancies identified after the standards were submitted for regulatory approval. The errors have been preliminarily classified as errata. NERC is posting the errata for a 30-day comment period to provide stakeholders an opportunity to identify any material impacts associated with the errata that staff may have missed.

The reliability standards affected are:

- PRC-016-0 System Protection System Misoperations
- TOP-005-1 Operational Reliability Information
- TPL-001-0 System Performance Under Normal Conditions
- VAR-002-1a Generator Operation for Maintaining Network Voltage Schedules
