Practice Guides may be developed following policy discussions with industry stakeholders. CMEP Practice Guides are posted on the NERC website for transparency.

NERC added two new self-identified alignment issues pertaining to the CMEP practice guide on considerations for ERO Enterprise CMEP staff (CMEP staff) on 'Using the Work of Others' and 'Registered Entities that Delegate Reliability Tasks to a Third-Party Entity'. The ERO Enterprise Program Alignment Process is intended to enhance efforts to identify, prioritize, and resolve alignment issues across the ERO Enterprise. Using this process, NERC captures identified issues from the various resources in a <u>centralized repository</u>. The Consistency Reporting Tool uses a third-party application, EthicsPoint, which allows stakeholders to submit consistency issues—anonymously, if desired.

#### **NEW Extreme Weather Heightens Reliability Risks this Summer**

NERC's 2022 Summer Reliability Assessment warns that several parts of North America are at elevated or high risk of energy shortfalls this summer due to predicted above-normal temperatures and drought conditions over the western half of the United States and Canada. These above-average seasonal temperatures contribute to high peak demands as well as potential increases in forced outages for generation and some bulk power system equipment. #### **BOARD OF TRUSTEES AND FERC ACTION**

#### **Statement on FERC May Open Meeting Action**

At its monthly open meeting, the Federal Energy Regulatory Commission (FERC) approved in part and denied in part <u>NERC's petition</u> for revisions to its Rules of Procedure regarding its compliance monitoring and enforcement program. The order approves revisions for the Personnel Certification and Credential Maintenance Program in ROP section 600, the Training and Education Program in section 900, and Confidential Information in section 1500. The order also approves in part and rejects in part proposed revisions to the Compliance Monitoring and Enforcement Program ("CMEP") in section 400, Appendix 2, and Appendix 4C. The ERO Enterprise will submit a compliance filing within 60 days as directed by the Order.
