NEW Align Planned Maintenance

Align Release Notes Posted

During the August 17, 2023 maintenance outage, the Align system will be deploying modifications to correct existing functionality or to improve user experience. The modifications include but limited to the following: ability for Registered Entities to print from all the forms in the Enforcement and Mitigation modules (draft finding record, finding records, mitigation records, notification records, request for information, etc.); ability to delete risk factor questions; ability to create Periodic Data Submittal for TPL-001-5.1; update due dates for Inherent Risk Assessment Questionnaires. The Release Notes provide details on the specific changes and indicate the users affected, as well as if any training materials need to be modified. BOARD OF TRUSTEES AND FERC ACTION

NEW NERC Filings

On August 14, 2023, NERC submitted an unaudited report of NERC's budget-to-actual variance information for the second quarter 2023. This compliance filing is in accordance with FERC's January 16, 2013 Order, which approved a Settlement Agreement between the FERC Office of Enforcement and NERC, related to findings and recommendations arising out of its 2012 performance audit.

NEW Board Approves 2024 Budget, Modernizes Committee Responsibilities; Technical Session Highlights Transmission Transfer Study

NERC's Board of Trustees concluded its August meeting in Ottawa, acting to approve the 2024 budget, enhance Board oversight of standards development, and review the approach for a major study on electricity transfer capability between transmission planning regions. Participants also commemorated the 20th anniversary of the 2003 Northeast blackout, which was commemorated by the ERO Enterprise with a video, "[The Grid – 20 Years of Progress Since the 2003 Northeast Blackout](#)" reflecting the ERO Enterprise's progress toward a more reliable and resilient grid that was released earlier this month.
